## MEMBERSHIP CATEGORY

★ The membership of the association shall be composed of :

**(a).Office Bearers**

**(b) Directors / CC Member**

**(c) Members**

★ **Office Bearers:** The elected representatives, The President, The V.P, Secretary, Treasurer comprise of Office Bearers and will have Executive Powers of the Association

★ **Directors / CC Member:** May at any time be created by the Office Bearers and defined by different classes of members and may define their respective rights and privileges. The decision of the Core Committee will be final in all cases.

★ **Directors:** The directors will be elected by the Office bearers and the number of directors to be elected is left to the discretion of the office bearers

★ **Active Members:** A firm or company having established place of business in Mysore District and recognized by the DEAL - IT and or by its members shall be eligible for membership as an active member of the association provided an application is made and accepted by the Executive Committee. However only one office of a firm or company shall be admitted as an Active Member of the Association. And thus selected member will be eligible for one vote only.

★ **Associate Members:** Any firm or company, which is regularly engaged or associated with IT-Hardware with a branch in Mysore District shall be eligible for associate membership of the association. Only the Prop / Partner of such firm will be eligible to participate in the voting process of the association but their representatives shall have no right to vote in the proceedings of the association. However any one member nominated by such prop / company will be allowed to participate in all the activities of the association.
